EXECUTIVE SUMMARY

BCJ - Quarterly Monitoring & Compliance Report (October – December 2023)

During the period October - December 2023, eighteen (18) Notices of Breach of Licence were issued, all of which related to broadcast radio licensees.

Thirty (30) contacts were recorded for the period under review. Of this number, twelve (12) were complaints which resulted in investigations of broadcast radio stations. Eighteen (18) were queries and comments about other operational issues pertaining to licensed operators and the work of the Commission.

All twelve (12) complaints were matters relating to content standards. This represented a decrease of five (5) when compared with the previous quarter.

Regarding technical matters, four (4) subscriber television (STV) licensees were inspected. One of the inspections resulted from a complaint while the other three (3) were conducted to determine the licensees' technical compliance.

In relation to the payment of the annual licence fee, twelve (12) STV operators, or 31% of all licensees paid in full; five (5) or 13% made partial payments and twenty-two (22) or 56% were non-compliant. There was a decrease in the number of full payments recorded when compared to the previous quarter while there was no change in the number of licensees who made partial payments. There was an increase in the number of non-compliant licensees.

CONTACTS WITH THE COMMISSION

Thirty (30) contacts were recorded for the period October – December 2023 as seen in Table 1 below.

CONTENT STANDARDS COMPLAINTS

The Commission investigated twelve (12) complaints relating to the broadcast of problematic content. The number of complaints investigated decreased by five (5) when compared to the previous quarter.

Table 2 details the nature of the investigations conducted by the Commission between October and December 2023.

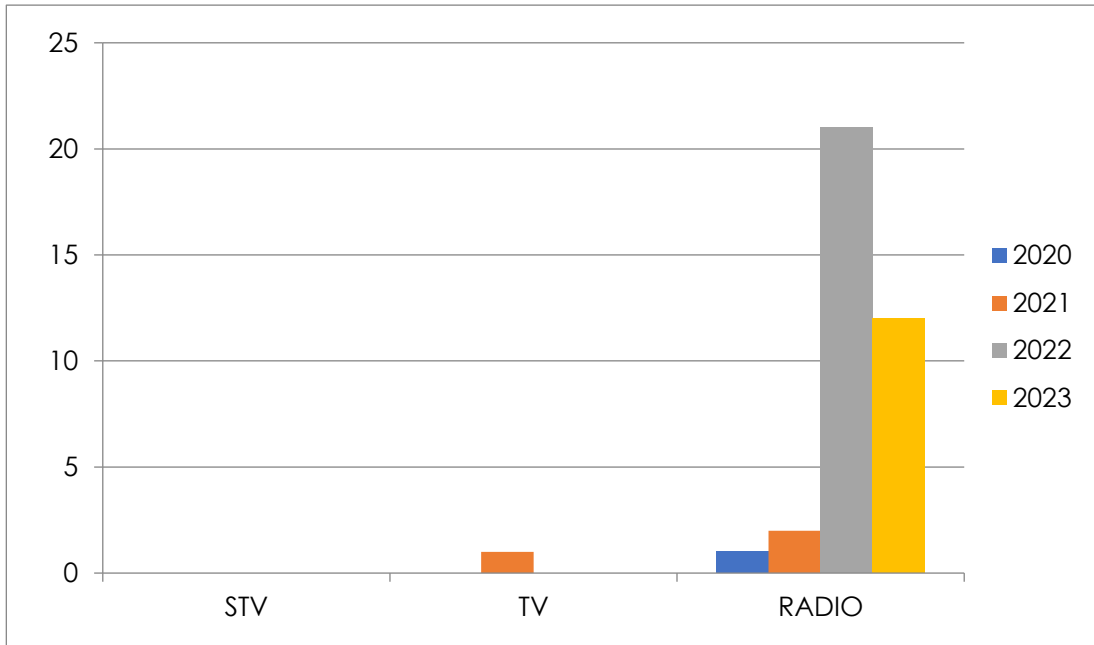

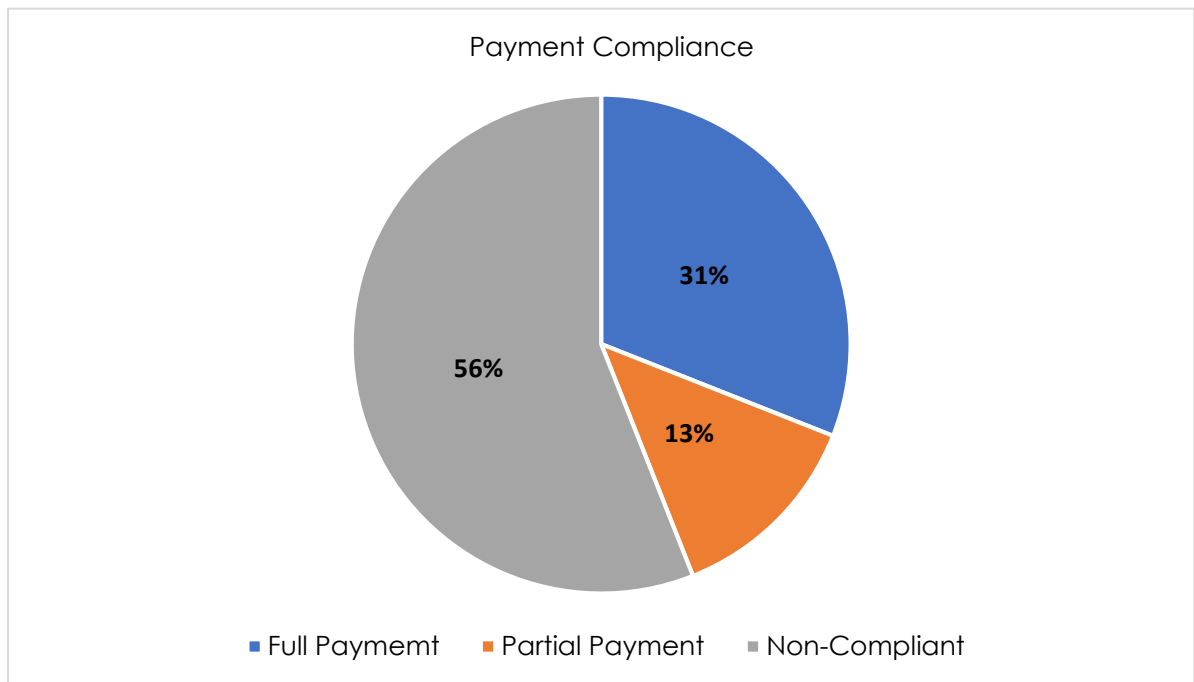

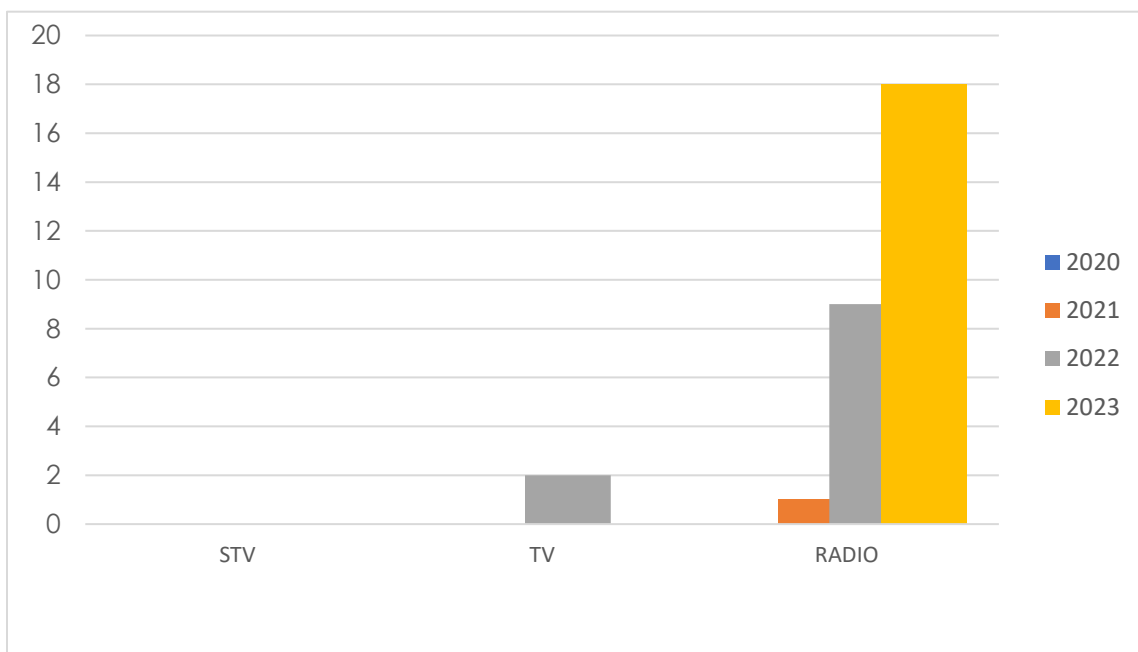
